It is your responsibility to ensure that you are on the list of voters and a mail in ballot voting package will be mailed to all Adult Members who the Nation has an address for. Please be advised that a Referendum Vote has been called pursuant to and in accordance with the Lax Kw'alaams Indian Band Indian Band Settlement Trust Agreement (2003). The consequences of the vote are described on the reverse side of this Notice for your information.

The following question will be asked of the Adult Members of Lax Kw'alaams by secret ballot:

"DO YOU APPROVE THE PROPOSED AMENDMENTS TO THE LAX KW'ALAAMS INDIAN BAND SETTLEMENT TRUST AGREEMENT (2003)?"
